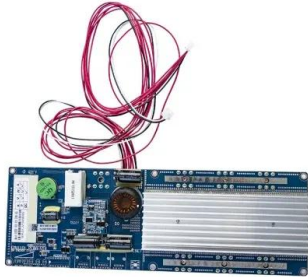

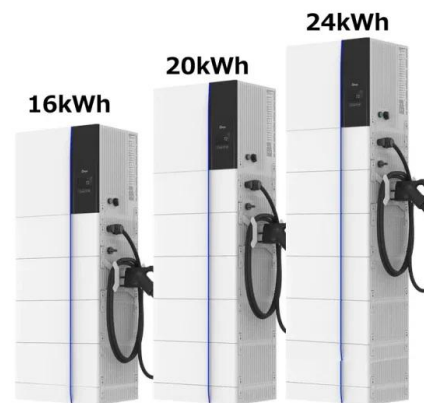


## PLUGGING INTO THE FUTURE: LAUNCH OF RESEMBID THROUGH ANGUILLA...

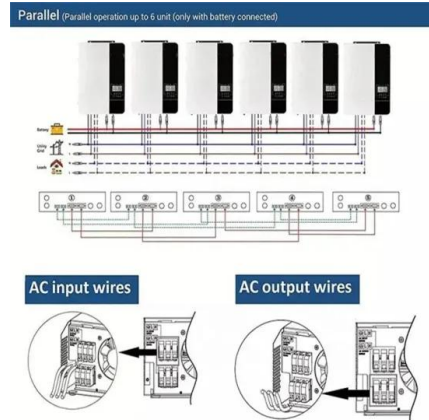
