When did Malta become a member of the European Union?

Malta joined the European Union in 2004 and adopted the euro on 1 January 2008. The Netherlands is a founding member of the European Union and one of the first countries to adopt the euro on 1 January 1999. Poland joined the European Union in 2004 and is currently preparing to adopt the euro.

Does Malta exchange lira coins?

The Central Bank of Malta exchanged Maltese lira coins until 1 February 2010 and will continue to exchange Maltese lira banknotes until 31 January 2018. Malta joined the European Union in 2004 and adopted the euro on 1 January 2008.

Are Malta and Cyprus achieving 'sound' and 'sustainable' public finances?

Since their accession to the EU, Malta and Cyprus have undertaken a remarkable fiscal adjustment to achieve 'sound' and 'sustainable' public finances as required by the Maastricht convergence criteria. Between 2003 and 2006, the budget deficit fell from 6.3% of GDP to 1.5% in Cyprus, and

from 10% to 2.6% in Malta.

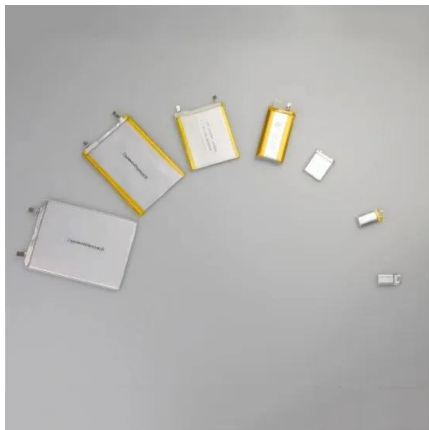

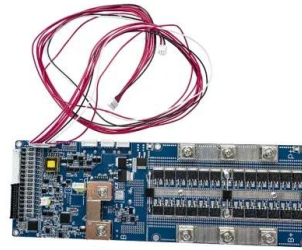
