Overview

Are France's solar PV auctions dwindling?

Aside from the rooftop solar PV auctions, France also held a ground-mounted tender in March of this year, which awarded nearly 1GW of PV capacity. After awarding over 500MW of capacity in the fifth tender, held in August 2023, the numbers have dwindled in the following auctions, as shown in the chart below.

Are solar panels a good option in France?

More and more companies are either selling, or installing, solar panels for people across France. This, coupled with rising energy costs, continues to make solar panels appear an attractive alternative to gas or electric energy sources, for both homeowners and businesses. Here we answer eight common queries about solar panel installation in France.
