Reliance's Singapore office gets new head, new business

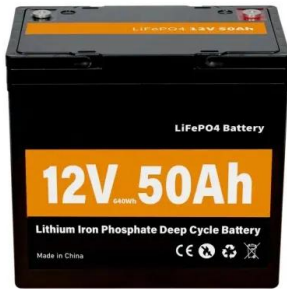
