The BLM's preferred alternative in the updated Western Solar Plan would provide approximately 22 million acres of land open for solar application, giving maximum flexibility to reach the nation's clean energy goals.

The Department of the Interior today announced that the Bureau of Land Management (BLM) is advancing nine solar projects on public lands that could potentially power nearly 2 million homes with clean energy.

10 large solar projects in the U.S. FirmoGraphs analyzed thousands of project applications from the Public Utilities Commission (PUC) agencies, environmental permitting agencies, and the FERC across the U.S. and selected ten projects in geographically diverse areas valued at \$250 million or more that are anticipated to commence construction in . What's new in solar energy development across the west?

WASHINGTON — The Department of the Interior today announced an updated roadmap for solar energy development across the West, designed to expand solar energy production in more Western states and make renewable energy siting and permitting on America’s public lands more efficient.

How much will solar projects cost in 2023?

Construction will commence in 2024 and is expected to be completed in 2025, costing \$280 million. FirmoGraphs is tracking more than 100 very large solar projects starting construction in 2023 with a total estimated value of nearly \$40 billion.

How many acres of public lands are needed for Western Solar Plan?

In considering updates to the Western Solar Plan, the BLM worked closely with the Department of Energy’s National Renewable Energy Laboratory to examine forecasts for national clean energy needs and determined that approximately 700,000 acres of public lands would be needed to meet those goals.

What is a large-scale solar energy project?

The project is a large-scale solar energy initiative developed on 10,000 acres of land north of the city of London near Plumwood in Madison County. The project is expected to have a maximum generating capacity of up to 800 MW of clean electricity. It will also include a Battery Energy Storage System (BESS) of up to 300 MW.

Will Dominion Energy develop a Rocky Run solar project?

Dominion Energy, Inc. will develop the proposed Rocky Run Solar project on the southeastern side of Brunswick County, near Harris Crossroads, along its border with Greensville County, Virginia. The project site covers about 10,000 acres of land and will generate up to 300 MW of electricity to power 75,000 homes at peak output.

How much does a solar project cost?

The project is expected to start construction in 2024 and enter commercial operation in the first quarter of 2025. According to the 2022 Annual Technology Baseline (ATB), solar with co-located energy projects will cost \$1,540/kW. Based on this value, FirmoGraphs estimates the project will cost \$780 million.

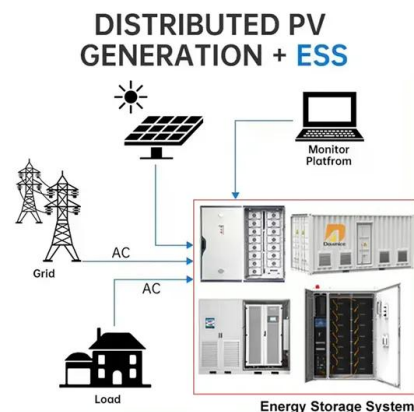

Channel Islands' inaugural solar farm set for completion by late 2024.

The Channel Islands are set to welcome their first solar farm by the end of 2024, marking a significant milestone in the region's shift towards renewable energy.
